

The application process and management trial measures for the Shaolin Kung Fu DuanPin(Ranking) System and Training Base

"Kung Fu from all over the world comes from Shaolin Temple". Shaolin Kung Fu, as one of the first batch of national intangible cultural heritage in China, is an excellent traditional Chinese culture that is deeply loved by the people at home and abroad. In order to better inherit Shaolin Kung Fu, serve human health, and enable people who love Shaolin Kung Fu to systematically and scientifically learn Shaolin Kung Fu, the Shaolin Temple has authorized the establishment of the "Shaolin Kung Fu DuanPin System Committee" as the unified management body for Shaolin Kung Fu Duan Pin system, to organize and promote Shaolin Kung Fu Duan Pin system worldwide.

The Shaolin Kung Fu Duan Pin system is divided into Duans, Pins, and honor Duans and pins. Both the Duans and Pins are divided into nine levels, and both the Duans level and Pins level promotion have strict theoretical and technical evaluation standards. The order of Duans from low to high is one to nine; The order of Pin from low to high is from first Pin to ninth Pin .

Those who pass the evaluation test of the Shaolin Kung Fu Duan Pin System will be awarded the corresponding level of "Shaolin Kung Fu Duan pin System" grade certificate, badge, and belt by the Shaolin Kung Fu Duan Pin System Committee. At the same time, they will receive the world's unique Shaolin ID number and be able to conduct online identity authentication and grade certificate through the Shaolin APP.

In response to the needs of Shaolin Kung Fu enthusiasts and to accelerate the standardization construction of Shaolin Kung Fu and the promotion of Shaolin Kung Fu Duan Pin System, in accordance with the "Shaolin Kung Fu Duan Pin System" and relevant documents, Songshan Shaolin Temple has applied for the licensing of Shaolin Kung Fu Duan Pin System Teaching Base for various martial arts towns, martial arts schools, martial arts institutions, individual quan complex research associations, as well as martial arts department from various schools, enterprises, communities, and townships, Develop the "Trial Measures for the Application Process and Management of Shaolin Kung Fu Duan Pin (grade) System Training Base".

1、 Requirements for applying for the certification base of the Duan Pin system training base:

1) Staff Requirements:

(1) At least 3 persons in charge of the certification base have 6 Duan or over certification positions

(2) There must be one staff member who has the ability to use computers to establish entry personnel data and submit electronic documents.

Note: If the above personnel have the corresponding qualifications and abilities, they can have multiple roles.

2. Working facilities Requirements

(1) The licensing point should have a fixed office space, communication address, and contact phone number.

(2) The licensing point should have computer office conditions.

(3) The licensing point should have teaching and examination venues that meet the requirements (including rentable venues).

3. Other requirements:

(1) If the regional evaluation center accumulates 150 or more people annually, they can apply to the Shaolin Kung Fu Duan Pin system Committee for licensing. (From January 2020 to present, any regional evaluation center with 150 people can apply for licensing.)

2. Application and approval process:

1. Download the "Application Form for the" Duan pin System Training Base "(see Attachment 1 below) and fill it out carefully according to the requirements of the form content.

2. The applying unit shall submit the signed application form to the Shaolin Kung Fu Duan Pin system Committee Office for review and signature. After the application form is approved by the Shaolin Kung Fu Section Duan Pin Committee, it will be given to the licensed unit as a "national level" The plaque of the "Intangible Cultural Heritage Shaolin Kung Fu • Duan Pin System Training Base" and a set of Shaolin Kung Fu Duan Pin System badges and belts (1-9 sections), as well as a complete set of books published in the "Shaolin Kung Fu Duan Pin System Series Tutorial", are used for display.

In principle, there should be no more than one licensing agency in each county (district). Under the same conditions, the first application shall prevail.

4. In special circumstances or for regional organizations that have done very good work in the promotion of Shaolin Kung Fu Duan Pin System, special applications can be submitted to the Duan Pin System Committee for licensing.

2、 Responsibilities and assessment requirements for the Duan Pin System Training Base:

1. Actively promote the Shaolin Kung Fu Duan Pin System.

2. Widely carry out training and exams on the Shaolin Kung Fu Duan Pin system, and issue certificate of achievement to those who pass the exam according to the prescribed authority.

3. Comply with national laws, consciously maintain the quality of Shaolin Kung Fu and the image of Songshan Shaolin Temple, actively promote the development of Shaolin Kung Fu. If any behavior is detrimental to the quality of Shaolin Kung Fu and Songshan Shaolin Temple, the Shaolin Kung Fu Duan Pin Committee will cancel its licensing qualification.

4. The licensing agency shall conduct at least two times evaluations annually, and the cumulative number of evaluations per year shall not be less than 150. If the assessment requirements are not met for two consecutive years, the Shaolin Kung Fu Section Quality Committee has the right to revoke its licensing qualification and retrieve the corresponding materials.

5. In order to standardize the licensing process, the evaluation points that have obtained the licensing must pay a deposit of one thousand yuan (1000 yuan) to the Shaolin Kung Fu Section Duan Pin Committee. If the licensing process is terminated or cancelled, the deposit can be fully refunded after the

corresponding materials are returned.

3、 Rewards

The Shaolin Kung Fu Duan Pin System Committee will regularly select advanced collectives and exemplary individual, and will commend and reward the winners.

4、 Other

1. This trial method is formulated and interpreted by the Shaolin Kung Fu Duan Pin system Committee. Any matters not covered will be notified separately.
